#### 2024/78 B4RN Full fibre for rural Northumberland. Members to receive information.

M Dickson-Green advised B4RN were a not for profit organisation, providing broadband to areas not commercially viable. 80% of the project is funded via BDUK, the remaining 20% through local investment/shareholders. The Barrasford project had been completed, and Kirkwhelpington commenced. Response in the parish had been phenomenal, with a desktop exercise currently being carried out. The broadband service charge would be £33/month, with a connection fee of £60. Reductions were available to those on benefits. If person's had less than two years on an existing broadband contract, the B4RN service could run alongside at a reduced cost of £5/month.
